SC /ST / PWD candidates should have secured PASS MARKS.

Age limit: Upper age limit is 27 years as on 01.04.2019.

3. Mode of selection:

- Selection will be through written test and interview.
- Call letters will be sent to the e-mail IDs of eligible candidates for attending the written test.
- Candidates will be shortlisted for interview based on their performance in written test.
- Date of the written test will be intimated by e-mail in due course. The written test will consist of objective type questions from engineering subjects in respective disciplines / specializations.

4. General conditions:

- Only Indian nationals need to apply.
- **Application fee of Rs. 500/- by DD in favor of 'Bharat Electronics Limited' payable at Chennai is required to be attached along with application.** SC/ST, PWD candidates are exempted from payment of application fee. There will be no reimbursement of fare for attending the written test. The outstation candidates called for interview separately will be reimbursed with Second class train fare by the shortest route between the correspondence address and place of interview on production of valid train tickets.
- Candidates employed in Govt./Quasi Govt. and Public Sector Undertaking is required to submit the application through proper channel or produce **"No Objection Certificate"** at the time of interview; without which such candidate will not be allowed to appear for the interview.
